INTERVIEW: KENNETH MILLER
SAM'S CAR WASH
W. INNES STREET
SALISBURY, NORTH CAROLINA

MR. MILLER WAS INTERVIEWED AT HIS PLACE OF EMPLOYMENT AT APPROXIMATELY 9:30 A.M. MILLER STATED THAT HE HAD TALKED WITH DETECTIVE AGNER AND GAVE THE STATEMENT REFERRED TO IN THE SEARCH WARRANT. HE STATED THAT HIS WIFE WORKS WITH AGNER'S WIFE AND HE HAD MENTIONED TO HIS WIFE THAT L. C. UNDERWOOD HAD BEEN IN AND HAD HIS CAR CLEANED. THIS RESULTED IN AGNER CALLING HIM FOR AN INTERVIEW.

MILLER STATED THAT UNDERWOOD WAS A REGULAR CUSTOMER AND VERY PARTICULAR ABOUT HIS VEHICLE. HE STATED THAT THE \$14.25 WAS A "SUPER WASH" AND THAT UNDERWOOD GOT THAT TYPE OF WASH ON OCCASIONS, BUT NOT ALWAYS.

MILLER STATED THAT THE "SUPER WASH" WOULD NOT INCLUDE THE SPECIAL SERVICES THAT HE REFERRED TO IN HIS STATEMENT TO AGNER. MILLER STATED THAT UNDERWOOD BROUGHT BOTH OF HIS VEHICLES IN ONLY ONE TIME ON THE SAME DAY TO HAVE THEM THOROUGHLY CLEANED. MILLER STATED HE NOTICED BLACK DUST ALL OVER THE CAR AND ASKED HIM WHAT IT WAS AND UNDERWOOD SAID IT WAS FINGERPRINT POWDER WHERE THE POLICE HAD DUSTED FOR FINGERPRINTS BACK ON FEBRUARY 1, 1994, WHEN THEY SEARCHED THE CAR, AND TOOK THE TRUNK MATS. MILLER STATED THAT TO HIS KNOWLEDGE THIS IS THE ONLY TIME THAT UNDERWOOD HAD BOTH OF HIS CARS CLEANED ON THE SAME DAY. THE TRUNK MAT WAS NOT IN HIS OTHER CAR WHEN HE BROUGHT IT IN FOR CLEANING EITHER. MILLER WAS SHOWN RECEIPTS AND CANCELLED CHECKS TAKEN FROM UNDERWOOD'S MONTE CARLO ON 12-13-95, BY REPORTING AGENT AND UNDERWOOD'S ATTORNEY'S DATED MARCH 10, 1994 IN THE AMOUNTS OF \$46 FOR THE MONTE CARLO AND \$55 FOR THE DODGE. MILLER STATED THESE AMOUNTS WERE CORRECT FOR THE WORK DONE ON UNDERWOOD'S VEHICLES, AND THAT HE WAS WRONG ABOUT THE DATES HE HAD GIVEN TO DETECTIVE AGNER IN HIS STATEMENT TO HIM IN NOVEMBER 1995, THAT UNDERWOOD HAD HIS VEHICLES IN DECEMBER 1993 OR JANUARY 1994. MILLER ADMITTED THAT IT WOULD HAVE BEEN IMPOSSIBLE FOR HIM TO HAVE CLEANED THE TRUNK MATS IN EITHER CAR IF THEY HAD BEEN REMOVED BY THE POLICE IN FEBRUARY 1994. MILLER SAID HE WAS GOING TO CALL AGNER AND TELL HIM HE WAS WRONG ABOUT THE DATES IN DECEMBER 1993, AND JANUARY 1994, THAT HE TOLD HIM HE HAD THE CARS CLEANED.

THE TRUNK MATS FROM BOTH VEHICLES BELONGING TO L.C. UNDERWOOD WERE REMOVED BY INVESTIGATORS DURING THE SEARCH ON FEBRUARY 1ST AND 2, 1994. AS THE RECEIPTS AND CANCELLED CHECKS SHOW, THE DODGE DIPLOMAT AND THE CHEVROLET MONTE CARLO, WERE ACTUALLY CLEANED ON MARCH 10, 1994 THIRTY-EIGHT DAYS AFTER THE TRUNK MATS HAD BEEN REMOVED FROM BOTH VEHICLES. IT WOULD HAVE BEEN IMPOSSIBLE FOR KENNETH MILLER OF SAM'S CAR WASH TO HAVE SHAMPOOED THE TRUNK MAT FROM THE CHEVROLET MONTE CARLO. AS HE TESTIFIED TO AT TRIAL, (T, VOL. 3, PP. 1121-1123) IF THE TRUNK MAT HAD BEEN REMOVED IN FEBRUARY 1994, AND THE VEHICLES WERE NOT CLEANED UNTIL MARCH 10, 1994. THE RECEIPTS WERE ENTERED INTO EVIDENCE AS DEFENSE EXHIBITS # 7 AND # 8 AT TRIAL. (T, VOL. 3, PP 1131-1132).
