JASON IS A STUDENT AT WEST ROWAN HIGH SCHOOL HIGHWAY #801, CLEVELAND. MRS. MILLER IS MY MOTHERS NAME, SHE IS MY GRANDMOTHER.

MY MOTHERS NAME IS SANDRA KAY. ME, MY MOTHER AND A EXCHANGE STUDENT LIVE TOGETHER. EXCHANGE STUDENT HAS BEEN WITH US SINCE SCHOOL STARTED, AUG. 17, 1993.

DO YOU WORK ANYPLACE?
BLUEBAY, HWY 70, NEAR THE MALL. THE NEW ONE. HOURS: WED., THURS, SATURDAY FROM 5:00 PM UNTIL I WANT TO GET OFF. USUALLY 8:30, 9:30, OR 10:30 PM. WORKED THERE FOR 5 WEEKS. JOB IS BUS BOY.
